From the High School

With Spring Break behind us we are in the final sprint toward graduation and the end of the school year. As we work to finish this school year strong we are busy preparing for the 2016/17 school year

Testing

The SAT and Pre-SAT testing was completed the week after spring break. With the State Department of Education changing from ACT to SAT this was the first year for our students taking the SAT. This brought challenges for our staff and students as we made the transition. To add a little more stress to the testing we were designated as one of the schools in Michigan that would have a monitor from SAT on site during the testing process. I am pleased to report that the testing went off without a problem; in fact the monitor sent an email to Mr. Candela and I to report what a nice job our staff and students did during the testing process. None of this would have been possible if not for the hard work of Mrs. Deneweth, her dedication to making sure that the testing went well cannot be overstated.

The M-STEP testing for the High School, in social studies and science, is being conducted this coming week. Our AP students are also busy preparing for the AP College Board testing to be held in May.

Scheduling

We are in the final stages of putting together our schedule for the coming school year. All student requests have been submitted and we are in the process of assigning students to their courses for the 2016/17 school year.

Duel Enrollment/Early College

This coming fall we will be running two Duel Enrollment courses through St. Clair Community College, on site here at the High School. We have 20 students that have signed up and expressed interest in taking the on-site college courses. In addition we will have students taking Duel Enrollment through Macomb Community College, mostly on line and through U of M Flint at the Lapeer County Ed Tech.

Evaluations

Teacher evaluations are ongoing at the high school. We are in the formal observation portion of the evaluations and will have them all completed by the May 1st.

Educational Technology Programs

Our students did great at the Skills Testing at the Ed tech.

Visual and Performing Arts

The Band recently completed their competition at the Regional Band Festival. Again this year the band received high honors taking a #1 ranking.

Mr. Miles and his crew are busy preparing for the spring play. This year's play is the musical "Annie". Practices are being held after school and on weekends. We have a large group of students participating in the acting and production of this year's play.

Athletics

With the spring sports season well underway there are games and contests taking place most days after school. All of our spring sports programs have full squads with a large portion of our student body taking part in a spring sports.
