Questions and Comments: Audience

Paulynn Bartlett - supports smaller class sizes, especially at lower grades, also concerned about moving 4th grade to AMS building. If 4th grade moves to AMS, we lose Title 1 support for that grade. 4th graders currently do Safety Patrol which helps keep younger students safe. Bussing and scheduling can also be a challenge. Would like to think outside of the box for alternate solutions such as redesigning the Library space. Did develop maps with potential solutions. If this is a temporary solution, why are we looking to spend money.

Adam Wetzel - As Band Director and 4th grade music teacher, will schedule time with Dr. Kalmar to resolve rumors including talk of eliminating music. OP music is not just choir. Music is essential to a child's development and would like to see it continue.

Heather Throop - as a parent of current 4th grade student, has concerns about these possible solutions. Asking if we could start with Bubble solution, then move to Interim in later years if needed. Could the OP students walk to AMS for special class, such as Music or Art? Concerned about younger students being exposed to older students regarding vaping, explicit actions, etc.

Amy Bowers - Parent of students 7th grade and below. Concerned that 4th graders may not be ready developmentally to be in the AMS.

Alyssa Tangney - Parent of six children and School of Choice. Came from larger school district with different building setup and it had the issues with safety. Also that their previous district allowed School of Choice granted full family.
